**VERIFICATION OF PARENT NOTIFICATION
OF
HEALTH AND IMMUNIZATION REQUIREMENTS**

A physical examination within the past year may be requested for initial enrollment in **kindergarten** or **first grade** in the district.

The Ohio Department of Health has established minimum requirements for immunizations of pupils in public and non-public schools. **Minimum state required immunizations for school year 2017-2018 are as follows:**

VACCINES	FALL 2017 IMMUNIZATIONS FOR SCHOOL ATTENDANCE
DTaP/DTP/DT Tdap/TD Diphtheria, Tetanus, Pertussis	Kindergarten 4 or more doses of DTaP, DTP or DT, or any combination. If all doses were administered prior to the 4 th birthday, a 5 th dose is required. If 4 th dose was administered at least 6 months after the 3 rd dose, and after the 4 th birthday, a 5 th dose is not required. Grades 1-12 4 doses of DTaP, DTP, DT or Td or any combination. 3 doses is the minimum for children 7 and up. Grades 7-12 1 dose of Tdap vaccine must be administered prior to entry.
POLIO	K-7 3 or more doses of IPV. The final dose must be administered on or after the 4 th birthday regardless of the number of previous doses; If a combination of OPV and IPV was administered, 4 doses of either vaccine are required. Grades 8-12 3 or more doses of OPV and IPV. If the 3 rd dose of either series was received prior to the 4 th birthday, a 4 th dose is required. If combination of OPV and IPV was received, 4 doses of either vaccine are required.
MMR Measles, Mumps, Rubella	K-12 2 doses of MMR. Dose 1 must be administered on or after the first birthday. The second dose must be administered at least 28 days after dose 1.
HEP B Hepatitis B	K-12 3 doses of Hepatitis B. The second dose must be administered at least 28 days after the first dose. The third dose must be given at least 16 weeks after the first dose and at least 8 weeks after the second dose. The last dose in the series (third or fourth dose), must not be administered before age 24 weeks.
Varicella Chickenpox	K-7 2 doses of varicella vaccine must be administered prior to entry. Dose 1 must be administered on or after 1 st birthday. The 2 nd dose should be administered at least 3 months after dose 1. Grade 8-11 1 dose of varicella vaccine must be administered on or after the first birthday.
MCV4 Meningococcal	Grade 7-8 One (1) dose of meningococcal (serogroup A, C, W, and Y) vaccine must be administered prior to entry. Grade 12 Two (2) doses of meningococcal *(serogroup A, C, W, and Y) vaccine must be administered prior to entry.
